- Develop the questionnaire to be sent to the selected companies to collect the information on their needs and their expectation for business process improvement
- Develop the list of documents which need to be share by the companies for analysis
- Interview the companies
- Write the report on a summary of findings, and propose the recommendations for each company.

## **Approaches:**

- Desk review
- Interview project team
- Interview, in-depth discussion with partners.
- Collect feedback for the draft report via email or meetings

## **Expected deliverables:**

A final report on needs assessment covering the minimum content:

- Survey questionnaires for companies
- Transcription of each in-depth interview
- Final report will include the following topics: detailed analysis of the companies, analysis and recommendations for each company and groups of companies based on the outcome of the assessment, prioritized actions, budget and timeline options for different intervention scenario.
